

Q4 How long have you been a member of this parish?







Q9 What is the highest level of school you have completed or the highest degree you have received?



Q10 What is your gender?



When these churches were built, we had double that number. We are mainly a blue collar community. Campbell is a community of many ethnic and racial backgrounds. Each group had their own church. At one time there were 8 churches in Campbell. When the decision to merge or collaborate was made, a gamut of emotions were felt by the parishioners. Many second generation parishioners remember their grandparents stories. They were stories of pride, monetary sacrifice and the generosity of their time and their physical labor that built each church. The Diocese of Youngstown, in my opinion, planned the changes intelligently. As the process of merger or collaboration evolved, the parishioners were encouraged many times and in many ways to ask questions and to share their ideas. Unfortunately, many times parishioners came to meetings with their own personal agendas. Many felt that the process was too long. Waiting for years for the closure of buildings, made it more difficult for some parishioners. For some it could be likened to waiting 'for the other shoe to drop"!
